ORDER

On the basis of Art. 44, para. 2 of the Local Self-Government and Local Administration Act, in connection with Art. 9, para. 3, proposal four, Art. 19, para. 1, item 2 and para. 2, item 5 of the Roads Act, as well as in connection with Art. 17, para. 3, item 3 of the Regulations for the Implementation of the Roads Act, Art. 13, para. 2 of the Ordinance on the Management of Municipal Roads, as well as a letter with reg. No. 111600-20918/06.11.2025 of the Directorate of the Ministry of Internal Affairs - Blagoevgrad,

I INTRODUCE

Temporary ban on the movement and parking of road vehicles (PPR) in a part of the fourth-class municipal road No. BLG1005 (II-19) town of Bansko - "Vihren" hut, from the "Shiligarnika" area (first parking lot) to the "Vihren" hut, for the period from **12.12.2025 to 12.04.2026.** To designate a place for turning around the PPR traffic in the area of the "Shiligarnika" area (first parking lot).

MOTIVES

By letter with entry No. 33-25-3001/08.12.2025 to the Municipal Administration of the town of Bansko from "Yulen" AD, in its capacity as concessionaire of "Ski-zone with center Bansko", the company has made a request pursuant to Art. 17, para. 3 of the Regulations for the implementation of the Roads Act and Art. 13, para. 2 of the Ordinance for the management of municipal roads, for the introduction of a temporary ban on the movement and parking of road vehicles on part of the fourth-class municipal road No. BLG1005 (II-19) town of Bansko - "Vihren" hut, from the "Shiligarnika" area (first parking lot) to the "Vihren" hut.

Fourth-class municipal road No. BLG1005 (II-19) Bansko - Vihren hut, during the winter tourist season, in the area after the first parking lot in the Shiligarnika area, intersects in several places with the existing ski slopes, operating in the winter period from December 2025 to April 2026. Therefore, there is the hypothesis of Art. 9, para. 3, sentence four of the Roads Act, namely - the emergence of a danger to traffic safety. This danger exists until the ski slopes cease to operate at the end of the winter season.

In addition, during this period, numerous vehicles are congregating in the road section at the first parking lot in the "Shiligarnika" area, which leads to traffic jams. As a result of this and given the weather conditions during this period, the access of emergency medical vehicles in case of need in case of accidents is hindered. Given the above circumstances, there is a danger to the safety of

traffic on the specified road section.

In view of the above reasons, there are grounds for introducing a temporary ban on public use of the section of the road from the "Shiligarnika" area (first parking lot) to the "Vihren" hut.

On the basis of Art. 17, para. 4 of the Regulations for the Implementation of the Roads Act, when temporary bans on public use of roads are introduced for more than 8 hours, the owner of the road must signal and indicate a bypass route. In the present case, there is an objective impossibility to indicate a bypass access route, given the lack of bypass roads in the area. Given this circumstance, a turning point should be introduced in the area of the "Shiligarnika" area (first parking lot).

For parking purposes, access to parking lots managed by the concessionaire "Yulen" AD should be ensured by introducing a pass-through regime.

Given the existence of a danger of road accidents and to ensure the life, health and property of citizens, this order is issued under conditions of urgency pursuant to Article 73 of the APC.

On the basis of Art. 74 in connection with Art. 60, para. of the APC, I order the preliminary execution of this order, since the delay in the execution of this order may result in significant and difficult to repair damage, namely affecting the life and health of vehicle drivers, passengers and tourists practicing winter sports in the "Ski area with center Bansko", in the area of "Shiligarnika" (first parking lot).

On the basis of Art. 9, para. 5 of the Roads Act, the temporary ban on the movement and parking of road vehicles (RPV) introduced by this order on a part of the fourth-class municipal road No. BLG1005 (II-19) town of Bansko - "Vihren" hut has been coordinated with the authorities of the Ministry of Interior - Regional Office of the Ministry of Interior - town of Blagoevgrad with a letter with reg. No. 111600-20918/06.11.2025.

This order shall be made public by posting it on the Internet. Bansko Municipality website - http://bansko.bg/.

The order is subject to appeal within one month of the announcement of its issuance. through the Mayor of Bansko Municipality before the Administrative Court - Blagoevgrad.

On the basis of Art. 180, para. 1 of the APC, the challenge does not suspend the execution of this order.
